- Almost a 10% YOY Increase for our Special Education students.
- Over 10% Increase in math for our African American students.
- New students did slightly better at K5.
- No notable differences in New/Returning students at MS.

**HS Highlights:**

- Overall decrease in growth
- Significant decline for students with an IEP.
- 9<sup>th</sup> Grade continues to be the primary area of concern.
- Returning students did better than New students by almost 10%.
